Smooth progress for construction of new Haeundae-gu office to be completed in 2026

Following a design competition held in February last year, Haeundae-gu selected the most successful design in May for the new Haeundae-gu office in order to make the transition to

the new building future-oriented and smooth. Now, the working design stage of the process has been completed, a presentation will be organized in order to allow for input and feedback

from residents. After completion of the working design by October this year, construction is expected to begin by the year end, and will be completed in 2026. The New Haeundae-gu office

will be a more pleasant and eco-friendly space with various convenient facilities and a larger parking lot space to be provided for local residents.

Seventeen items covered by Resident Safety Insurance for disasters or accidents



Haeundae was the first district in Busan to introduce Resident Safety Insurance and has resumed it after three years. In addition to nine items covered by the insurance given by Haeundae, residents are eligible to be covered for another

eight items insured by Busan city, making seventeen items in total for compensation coverage. Duplicate compensation is possible even if you are covered by another insurance policy or eligible for disaster aid. The insurance is automatically

provided to all Haeundae-gu residents including registered foreign residents and Koreans with foreign nationality residing in the area. Compensation is up to ₩100 million from a minimum of ₩300,000.

Insurance Coverage Contents covered by Haeundae-gu

Injury from righteous cause; legal support for medical accidents; death by injury from bike accidents; aftereffects of injury from bike accidents; death by drowning; treatment costs for silver zone accidents; surgery costs for burns; treatment costs for emergency medical procedures when bitten by a dog; youth abduction; kidnapping; hostage incidents.

Insurance Coverage Contents covered by Busan City

Death by explosion, fire, collapse, landslide; aftereffects of injury from explosion, fire, collapse, landslide; death by injury while using public transportation; treatment costs for school zone traffic accident injury; death by natural disaster; death by social disaster (except for infectious diseases); death by acute infection.





Dalmaji Oncheon (hot spring) Festival back after four years

The 38th Haeundae Dalmaji Oncheon (hot spring) Festival took place in the Haeundae beach area on Daeboreum of February 5th, the first full-moon day (the 15th day of the first month of the lunar calendar). The festival has returned to the site after a four-year hiatus since the outbreak of the COVID-19 pandemic. For the festival, various activities including, a dance drama, burning Daljip (a five-story daljip made of pine tree branches), and a ganggangsullae (Traditional Korean dance) were organized for visitors to participate in and enjoy.

Foreign parents to receive 'the monthly salary' with a baby whose birth is registered in Korea



Korean government provides every household that has a baby under a year old with 'the monthly salary for parents', a policy introduced by central government in an attempt to promote childbirth. The salary of 700,000 won will be paid to households that have a baby under a year and those with babies aged between 1 and under 2 years

will be paid 350,000 won per month. In the case of a baby that stays in daycare, the payment will be adjusted by deducting the daycare subsidy of 514,000 won, and the remaining amount of 186,000 won will be paid the following month. The parents can apply for the monetary support when they visit an administrative welfare

center that covers their address to report the baby's birth or they can visit www.bokjiro.go.kr or [www.w.gov.kr](http://www.w.w.gov.kr) to apply. Providing the children have Korean nationality, then they are eligible for the support even if both parents are foreign residents.

Korea to lift indoor mask mandate



The government ended the indoor mask mandate from Jan 30th. However, masks still remain mandatory in medical facilities, pharmacies and infection-prone venues and when riding public transportation. Infection-prone venues include skilled nursing facilities,

long-term medical care institutions and welfare centers for disabled people. Modes of public transportation include buses, trains, subways, passenger ships, chartered buses, taxis, aircraft, and kindergarten and school buses.
