
## Famous Places to Walk in Haeundae, Alongside the River, the Ocean, and Spring Flowers

**A Landmark of Centum City –  
APEC Naru Park,**




If you come out of exit 12 of Centum City Subway Station and walk for 10 minutes, you will arrive at Naru Park. Here, there are walking and jogging paths, and a diverse range of trees have been planted around the area. A sculpture to celebrate the APEC Summit was also built in the park.

**Elegant yachts in one spot –  
Suyeongman Bay Yachting Center**



As you enter the yachting marina surrounded by skyscrapers, both large and small yachts come into view. It was also the location of the 1st to 15th Busan International Film Festival opening ceremonies, until the Busan Cinema Center was built. More than one million tourists visit each year to experience yachting.

**Filled with youth and romance –  
Cinema Street**



On Haeundae Cinema Street, which was modeled after the Main Square of Santorini in Greece, the Gwangan Bridge, Igidae and Oryukdo Islands can be seen from the view. Especially, the night-time allows visitors to enjoy iconic ocean sights of Busan under the illuminated Gwangan Bridge. It is also entertaining to see the films that were set in Haeundae, and posters of movies that had as many as ten million box office views decorated on the walls of Cinema Street.

**Dongbaekseom Island with full –  
bloom camellia flowers**



As you walk along the urethane walking paths in Dongbaek Island, where camellia flowers are in full bloom, you will come across Nurimaru APEC House. This is where the APEC summit was held in November 2005. If you climb down close to the coast, you can see the 'Haeundae Stone Carving,' where Choi Chi-won, a famous scholar from the Silla Dynasty in Korea, carved 'Haeundae' into a rock.



## Foreign Residents of Haeundae are Covered by Resident Safety Insurance

Haeundae-gu has implemented resident safety insurance, which covers most household safety accidents regardless of whether the person is at fault or not. Anyone registered as a resident of Haeundae-gu, including foreign nationals, is covered by this insurance. The subscription period is from February 1st to January 31st of next year, and overlapping compensation with individual insurance, Busan Citizen Safety Insurance, and disaster relief funds is possible. An insurance claim is required to be filed within three years from the date of the accident.

### Haeundae-gu Resident Safety Insurance Coverage

#### • Coverage 1

Regardless of whether or not an individual is at fault, injuries occurred due to falling, tripping, getting a sprain, getting run over, being rolled over, being hit, collapsing, becoming trapped, cut, slashed, stabbed, physical misalignment, electric shock, explosion, fire, burn, suffocation, submersion, injury by animals, compression, and other accidents.

- Compensation limit- Up to 200,000 won per person for injury medical expenses (30,000 won deduction), 5 million won per person for death and funeral expenses (no deduction)

#### • Coverage 2

Compensation and medical expenses for car accidents involving children (0~12-years-old) as a pedestrian

- Compensation limit- Up to 500,000 won, depending on injury severity
- ☎ Compensation claim can be filed at 1566-3000



### Busan Citizen Safety Insurance Coverage

Covered Items	Compensation
Injury or death from fire, explosion or collapsing	20 million won
Permanent injury after fire, explosion or collapsing	20 million won
Injury or death from public transportation accident	15 million won
Permanent injury after public transportation accident	15 million won
Medical expenses for car accident in a school zone	10 million won
Death from infectious disease	1 million won
Death from natural disaster	10 million won
Death from social disaster	10 million won
Expenses for medical diagnosis of injury and compensation for victims 12-years-old or under	10 million won

- ☎ Compensation claim can be filed at 1522-3556

★ If an individual is registered as a resident in Haeundae-gu as of the date of the accident, the person still can be covered by the insurance, even if the person has moved to another area or had an accident in another region in Korea.

## Claim Compensation for Industrial Accidents at Foreign Missions in Korea Free of Charge

Foreign missions in Korea will be able to represent workers of their equivalent nationality in asking for compensation for an industrial accident free of charge. This will help workers with foreign nationalities in Korea who were not able to previously apply for compensation for an industrial accident.

These were sometimes due to communication issues, lack of information or financial burden, preventing them access a claim. Until now, only a certified public labor attorney or lawyer, other than a direct family member of a migrant worker was allowed to represent them asking for compensation. This led the victims

not to be able to receive compensation in time or having to pay excessive fees to brokers. Thanks to the system improvement, foreign missions in Korea including embassies can be a proxy for those who have moved to Korea for work in applying for compensation for industrial accidents.
